ENTRIES FOR TESTS WILL ONLY BE ACCEPTED FROM GUNDOGS REGISTERED AT THE KENNEL CLUB IN THE GUNDOG GROUP, (Reg.J1a 6a(i) & B20) and if a registered dog has changed ownership the TRANSFER must be applied for before the closing of entries. Entries not accepted without fees.

**Definitions:**

Novice Dog / Novice Handler: Confined to dog /s or handlers that have not received a place or COM in any Classified Novice GWT, Open GWT or Field Trial on the date of the Test

Special Puppy: confined to dog /s less than 2 years of age on the date of the Test

Veteran: confined to dog /s greater than 8 years of age on the date of the Test

The above are all Unclassified Classes which means restricted by conditions as determined by the Golden Retriever Club.

The following classes of competition are recognised by The Kennel Club as Classified GWTs:

- Puppy: confined to dog /s less than 18 months of age on the date of the Test
- Novice: confined to dog /s which have not gained a place or COM at a Field Trial, been placed 1st, 2nd or 3rd in an Open GWT or 1st in a Novice GWT held in accordance with The Kennel Club Rules and Regulations as at the date of the Test
- Open: open to all dog /s, although preference may be given to dogs which have gained a place or COM at a Field Trial, been placed 1st, 2nd or 3rd in an Open GWT, or won a Novice GWT as at the date of the Test
